

Southern Security VISA Credit Card

Quick Reference

- Starter limits of \$500; average limits of \$1200; higher limits upon request.
- Same rate on purchases, balance transfers and cash advances.
- Southern Security's VISA credit card is accepted anywhere you see the VISA sign.
- 24-hour fraud protection and Verified by VISA.
- Earn rewards with Rewards VISA. See Rewards Terms and Conditions for more information.

Application & Approval

- There is an application for the card.
- Credit approval is required.
- Payroll information (last pay stub or equivalent) will be requested.
- Upon approval, card will be mailed to the address of record.

How do I earn Rewards?

- **Use your credit card**
 - To earn rewards, simply make purchases anywhere your Rewards Visa is accepted. All purchases are subject to authorization by us.

- Earn 1 point per dollar of Net Purchases when you use your Rewards Visa credit card anywhere the card is accepted.
- **Transactions not eligible for Rewards**
 - Balance transfers and cash advances.
 - Fees or interest charges.
 - Fraudulent transactions.

How do I redeem my Rewards?

Other Facts about the Rewards Program

- Rewards cannot be redeemed if the account is not in good standing, or closed by the Cardholder or by us.
- Rewards awaiting credit to your account are not considered Cardholder property and may not be brokered, bartered, attached, pledged, gifted, sold, or transferred in any manner including disability, death, or in connection with any domestic relations dispute and/or legal proceeding.
- **Your monthly statement will include a section that will show the accumulated reward values.**

Program Changes

Southern Security FCU may make changes to the Rewards program and program rules at any time.

We may choose to:

- Change any part of the program or program rules.
- Terminate the program, or discontinue your participation in it for any reason.

Rewards may constitute taxable income to you and you are responsible for any tax liability that may arise from redeeming your Rewards. Please consult your tax advisor as Southern Security FCU, nor its employees provide tax advice.
